A Message from the Supreme Master at Arms

The following is an article from a 1937 Damon and Pythias magazine. While the message is 80 years old, the details continue to resonate for our Order. Enjoy.

All the responsibility of contacting the subordinate lodges with the spirit, pep, and program of Grand Lodge should not be laid upon the shoulders of the Grand Lodge. While it is true that the Grand Lodge must assume the greater share, and spend the greater amount of energy in this direction; it is nevertheless true that the majority membership of the Grand Lodge is composed of representatives selected by the subordinated lodges, authorized, and delegated to represent the local lodges in the annual convention.


This was certainly a once-in-a-lifetime experience and we four Americans were VERY proud and honored to represent YOU! THANK YOU for this opportunity!

Too often the subordinate lodges make the mistake of sending representatives the Grand convention with no other thought in mind than that of conferring an honor upon some past Chancellor. That may be a fine thing to do so far as the past chancellors are concerned. But it is not always the wise thing to do from the standpoint of the lodge. The average delegate, going up the first time from his lodge- for a short two-day convention, seldom knows what it's all about when it is all over. All that he can do is to take notes on the convention and bring a report back to his lodge. He gets acquainted with two or three of the officials, perhaps, and pals around with some other delegates whom he has never met before. But the routine of business is new to him, and he is new to the members of the Grand Lodge. He might be interested in something for the good of his, and other, lodges. But he is new, unacquainted, and hesitant. He doesn't form a very large acquaintance in two days, when it is all over he returns home to tell his lodge what the Grand Lodge has done. He has been an interested hearer has absorbed inspiration and pep like a sponge, has voted on Propositions entirely new to him, and wondered afterwards if voted right. He has voted for somebody for the office of Grand Outer Guard, probably because somebodyelse who was to know told him that this man was the logical one to vote for. He has supported other issues in the same way. What else could he do? He was never there before, and in all probability his lodge did not instruct him to regards to any matter that was to come up. But he has contributed very little, if anything, to the Grand Lodge.

It is a serious mistake for any subordinate lodge to act on the supposition that every past chancellor should go to Grand Lodge. The old rule of electing representatives for two years recognized the need of selecting a worthy past chancellor as representative and continuing him in Grand Lodge for two years or more. Subordinate Lodges will find it greatly to their advantage to select from their past chancellors one who is capable, willing to work and to sacrifice, who is loyal to the principles of the Order and re-elect him for several years, until he shall become, in the full mean all meaning of the term, a representative of his lodge, in this manner, greater value will accrue to the subordinate Lodge as well.

Perhaps a desire to confer honors may become a hindrance to the welfare and progress of the local lodge thereby defeating the purpose of the organization.

Furthermore, it is the bounden duty of each and every representative to make the coming session of Grand Lodge what it is to become, to go back to the subordinate lodge that has honored him with membership in the grand convention this year, and work like a Trojan in his local lodge, making even greater sacrifices than he did when he was Chancellor Commander, to help Chancellor Commander and other officers to put over the greatest program of activity ever attempted in his lodge. Every Grand Lodge Representative ought to be good for at least five or ten new members during the coming year. And he is good for it if he is good for anything at all. A little more sacrifice and a little more work for the lodge by the men who have the vision will turn the tide in the Grand Domain. It is a crime against the Order to accept from the Grand Lodge mileage per and representative and simply make attendance upon the session a two-day vacation, and then go back to lounge around a whole year at the expense and sacrifice of the lodge which elected you. By accepting the honor of the office and the Grand Lodge check, you obligate yourself and you should not be satisfied that the obligation has been met until you have turned in at least five applications for membership by initiation to your Keeper of Records and Seal. Is that too great a challenge, Brother Representative, or must we admit that we are not big enough for the job that we are endeavoring to hold? If knights who have vision are too lazy to try how may we expect those of impaired vision to step into the place of leadership that belongs to the Grand representative? It is where there is no vision that the people perish.

If each Representative in Grand Lodge this year will get five new members before the next session the revival will be on and the next convention will go down in the history of the Grand Domain as the Hallelujah Convention because of the rejoicing that will dominate the sessions.

There is only one way to do it, and that is to do it. We do everything else that we want to do, so let us really want to do this.

What say, Representatives, shall we tackle it? What has been done can be done again!
