#### 2016 SUPREME LODGE CONVENTION

The Committee responsible for organizing the convention, coordinating everything with the hotel, arranging for transport to and from the airport, selected the meals for the banquets, did an outstanding job. The guest rooms, meeting rooms, and the offices were conveniently located to the membership, well-lit and comfortable.

The business sessions of the convention were some of the quietest in recent memory; with few exceptions, the legislation was presented, discussed and disposed of in an orderly fashion. Supreme Chancellor L. Keith Stooksberry, Jr. did an outstanding job presiding over the sessions – bringing the gavel down only when needed, and over a three-day period that was a minimal number of times.

As part of our new look and our desire to be transparent, we offer for the first time a synopsis of the legislation adopted at the 2016 Convention. Of the Forty-Eight pieces of proposed legislation brought before the body for its consideration (some were withdrawn, defeated, declared moot or tabled) the following are those that were adopted and/or agreed to by the body.

Document B-1; SS. §1.16.018(b): Allowed for the voluntary monetary donations made by the grand lodges to the supreme lodge, to be counted in lieu of the per capita tax, to be used as the funds paid to the supreme representatives for mileage to and from the Supreme Convention.

Document B-2; SS §3.6.014(i): Corrected a mistake made at the 2014 Supreme Convention requiring the budget of a Grand Lodge to be in the hands of the voting members of the Supreme Lodge prior to the opening of the Supreme Lodge Convention.

Document B-3; Resolution: Established the Per Capita Tax at the rate of \$6.75 per taxable member for the 2016-2018 Biennium.

Document B-4; SC Article IX, §12: If ratified by at least a majority of the Grand Lodges, would give the Supreme Chancellor, upon the request of a certain number of members, the authority to pardon or commute decisions of the Supreme Tribunal, with certain restrictions.

Document B-7 thru B-15: Have to do with the manner in which mail is sent to and from the Supreme Tribunal and/or the manner in which it is sent to the Supreme Lodge.

Document B-16; SC Article VIII, §1: If ratified by at least a majority of the Grand Lodges, would give the members of the Knights of Pythias Foundation, Inc. (other than a Past Supreme Chancellor who have a vote by virtue of the position he/they achieved) voting rights at the Supreme Lodge Convention.

Document B-17: SS §1.13.09: Has eliminated the mandated \$15,000 from the Foundation for Pythian International for the Biennium 1966-1968.

Document B-20; SS §1.14.08: Mandates the Supreme Tribunal prepare a monthly report of docketed items on its calendar, to be sent to the Supreme Chancellor and the Supreme Secretary.

Document B-21, SS §1.5.023: Corrected the word "Your" to "Youth".

Document B-22, SS §1.17.024: Eliminated the mandatory \$1.00 per year increase in Per Capita Tax through July 31, 2020.

Document B-23; SS §7.2.05: Added additional days of remembrance to "Devine Day of Worship".

Document B-24; Resolution: Established the dates and location of the 2018 Supreme Lodge Convention.

Document B-29: Added a new "Three in One" Rank to the already Supreme Lodge approved Rank Work. It will be held over to 2018 Supreme Lodge Convention for final consideration and disposition.

Document B-33; §1.16.018: Increased the Expenses a Supreme Representative is entitled to from \$50.00 per day to \$75.00 per day for each day of the Supreme Lodge Convention.

Document B-34; SS §3.8.018: Will allow an additional member, in a subordinate lodge who is a Past Chancellor whose additional membership is in a Subordinate lodge of a Grand Domain in good standing, and a primary resident, shall be eligible to be elected to serve as a Grand Lodge Representative or Grand Lodge Officer with voice and vote and entitled to hold any Lodge office to which he may be elected in that Grand Domain.

Document B-35: Adopted the Proposed Knights of Pythias Foundation, Inc. Budget.

Document B-36: Resolution for a "Mission Statement" for the Knights of Pythias Foundation, Inc.

Document B-37; SS §1.14.42: Will now require a "Filing Fee" for various filings with the Supreme Tribunal.

Document B-38; SS §1.14.291: Specifies how and to whom a true copy of a complaint is filed with, and how it is to be sent.

Document B-39; SS §1.14.37: Specifies how monies collected by the Supreme Tribunal for fines are transferred to the Supreme Treasurer.

Document B-40; SS §1.14.30: Outlines the maximum time allowed before a filing shall be docketed by the Supreme Tribunal.

Document B-41; Resolution: The adoption of the Supreme Lodge Budget for the 2016-2018 Biennium.

Document B-42; added SS §1.4.09: In the event of the suspension of the charter of a grand lodge, operation of the grand lodge and subordinate lodges under its control shall be at the discretion of the Supreme Chancellor and under his direction and control.

Document B-43; added SS §2.5.044 (e): The Committee Public on Relations, whose duties shall include developing, organizing, instituting., and maintaining a program to promote the Order to the public, to organize programs and events for the public, to promote charitable and community service causes, and for the distribution of releases concerning such activities to media outlets.

Document B-45; Resolution: Authorizing "Actual Expenses" for a member, with the prior approval of the Supreme Chancellor, to visit the Rathbone Monument for an overview of its condition, and to write a complete report on his findings – to happen only once during a Biennium.

Document B-46; Resolution: That from this time forward our Brothers in Catania, Sicily shall be entitled to be known as the GRAND LODGE OF THE DOMAIN OF CATANIA (the Province of Catania) instead of the "Grand Lodge of Italy" and that they shall have the distinction of being the first legally formed Grand Lodge of Italy, with all of the rights and privileges attached thereto, pursuant to our Supreme Constitution and Statutes.

Their dedication and assistance was in keeping with the highest Traditions of Friendship, Charity and Benevolence.

## MORE READ & RIDE

Six Library Systems on the south shore of Massachusetts have taken advantage of the Read & Ride Program sponsored by the Grand Lodge of Massachusetts, funded by its charitable division. The bikes, boys and girls, cost very little in comparison to the publicity the Grand Lodge of Massachusetts is/has been receiving.

MA does it a bit differently by awarding bikes to the winners of the reading contests who are in the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> grades, a total of 6 bikes per library. Each winner receives a bike, helmet (with K of P decals as well as a plug for the store where we purchase the equipment at cost) and safety lights. The cost per library is less than \$450.00, including printed paraphernalia and certificates.

The program started last year with one library, but word has spread quickly and this summer MA has presented bikes in Stoughton, Needham, Lynn, Easton, Canton and Middleborough. We will also be sponsoring a winter contest, as we did last year, to the Library System in Stoughton for its winter vacation reading contest.
