

SUPREME CHANCELLOR'S MESSAGE

REBUILDING OUR ORDER

All members, of our order, know we have been loosing members for the last 20 years. We have 43 Grand Domains of which 10 have less than 125 members and six with more than 1000 members. Our total membership is about 30,000. This is our order. We must rebuild.

I ask, each member, who is going to take your place? Who will do your job as secretary, trustee, chancellor commander, fundraiser, or member? Now ask yourself these same questions. If you want to help rebuild our order you will find someone to replace you each year that you are a member. Teach each new member it will be their duty to replace themselves each year. This is an easy way for everyone to be involved in the rebuilding process.

We need to find a way to bring new applicants quickly into the lodge as knights. Perspective members should not wait on us. It should not take three months or three weeks to get a perspective member to the rank of knight. They should be brought into the lodge as knights almost immediately, so they will be members and can take part with the working of the lodge. It has been suggested new members may be knighted with an oath and then participate or observe the rank work within one year. This in no way would change our ritual. However, this can only be done with the approval of the Supreme Lodge voting in session. I would like to see this passed for a trial period of four years. This way we would give lodges that do not have the ability to do rank work an opportunity to bring in new members. We, as a Supreme Lodge, would know after the four year trial period if knighting by an oath helps rebuild our order.

Let me update you on Pythian Care. At the present time the By Laws and the Articles of Incorporation have been tentatively approved. The By Laws will be sent to the Internal Revenue Service along with the forms to acquire the 501-C-.3 status we are seeking for our charity Pythian Care. It is our hope and aim to have this done by the next Supreme Council meeting. When the approval for the 501.-C-3 has been approved the Supreme Domain will be informed.

Remember this is your order, therefore your responsibility to help rebuild our order. I know I can count on every member to support and help within their ability to do so.







Mel Pinkham, chairman of the camping program in the South Bay area, said that "the Pythian Youth Camp was created 50 years ago when the government gave the organization land with one requirement: to care for at-risk children by giving them a camping experience.

The Pythians raise funds, \$300 per child, to send approximately 350 children (ages nine to 12) to camp per year. According to Pinkham this money includes transportation, food, and other amenities. "It is 100 percent paid for, thru donations, for each child. Also the Memorial Children's Clinic in Long Beach has been giving children free medical examinations to go to camp."

The high elevation and snowfall in the Sequoias, 7,000 ft. and 19 inches respectively, require two weeks to prepare the camp for the summer. The camp is set up and run on a completely volunteer basis. "We have professional counselors, full-time cooks, and a full-time nurse," said Pinkham.

The Knights also present checks totaling over \$1,400 to Kids First and Cystic Fibrosis of Lafayette. Ms. Gail McCormick, director of Kids First, indicated that the funds would be used to help purchase a new sound system.

The Knights then presented rewards to 9 local elementary schools (Burnett Creek, James Cole. Mintonye, Klondike, Hershey, Wea Ridge, Cumberland, Washington, and Frontier) for their efforts to collect over 1,250 lbs of beverage tabs.
